About Houston Reed: Houston Reed just finished his ninth year as the Otero Junior College head men's basketball coach. While at Otero, Reed's teams have had one of the best overall junior college record in the state of Colorado winning a Region 9 Title, appearing twice in the Region 9 Title game, and winning Region 9 & District 9 Coach of the Year Awards. Otero has had five post players in the last four years sign with division one schools. Coach Reed returned to Otero after graduating from Otero in 2000. While playing at Otero, the Rattlers won two Region IX sub-region titles, and Reed earned all-region honors as a sophomore. Coach Reed also holds the record for most points scored in a single game in school history with 46 points vs New Mexico Junior

College, and currently sits 13th on the all-time scoring leader board. Following Otero, Coach Reed played for two seasons at Northern State University in Aberdeen, South Dakota under legendary coach Don Meyer. While at Northern, Reed was part of a conference championship and twice recognized with a NSU Scholar-Athlete award.
